GREATER VALLEY YMCA RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

1. In consideration for being permitted to utilize the facilities, services, and programs of the Greater Valley YMCA for any purpose, including but not limited to observation or use of facilities affiliated with the YMCA, without respect to location, the undersigned hereby releases, waives, discharges and covenants not to sue the GREATER VALLEY YMCA, its directors, officers, employees, and agents ("the releasees") from all liability to the undersigned, his or her personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, **WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE** while the undersigned is in, upon, or about the premises or any facilities or equipment affiliated with the GREATER VALLEY YMCA, without respect to location.
2. The undersigned hereby agrees to indemnify and save and hold harmless the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in, upon, or about the YMCA premises or in any way observing or using any facilities or equipment of the GREATER VALLEY YMCA or participating in any program affiliated with the GREATER VALLEY YMCA, **WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE**.
3. **THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE DUE TO NEGLIGENCE OF RELEASEES OR OTHERWISE** while in, about, or upon the premises of the GREATER VALLEY YMCA and/or while using the premises or any facilities or equipment affiliated with the GREATER VALLEY YMCA.
4. The undersigned further assumes full responsibility for any lost or stolen items while in, about, or upon the premises of the GREATER VALLEY YMCA and/or while using the premises or any facilities or equipment affiliated with the GREATER VALLEY YMCA.
5. The undersigned gives permission to the GREATER VALLEY YMCA to use photographs, film footage, or tape recordings which may include their own image (or family members) or voice for purposes of promoting YMCA programs.
6. The undersigned further expressly agrees that this forgoing release, waiver, and indemnity agreement cannot be altered in any way, and is intended to be as broad and inclusive as is permitted by the laws of the state of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. The undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement, and further agrees that no oral representations, statements, or inducement apart from the foregoing written agreement have been made.
